Henry County Schools has adapted our teaching, learning, and operations to welcome our employees and students back to a safe and encouraging learning environment for the 2021-2022 School Year.



Adaptation Strategies

Masks Required



Masks are required in all HCS Buses and buildings when responsible distancing is not possible

Personal Hygiene



Hand-washing and sanitizing will be encouraged throughout the day.

Responsible Distancing



Available space will be used to responsibly distance.

Signage



Appropriate signage will be displayed prominently throughout buildings.

Environmental Modifications



Changes to the physical learning environment, including ventilation improvements.

Self-Serve Sanitizer Stations



Hand sanitizing stations are placed in high traffic entrances and hallways.

Health Checks



All students and staff are encouraged to stay home when ill. School staff will be trained to identify symptoms of illness/sickness that warrant further clinic screening.

Seating Charts



Seating Charts implemented where appropriate.

Cleaning & Sanitization



Enhanced cleaning, disinfection, and sanitization of schools and buses.

Henry County Schools closely partners with the Georgia Department of Public Health to make a range of decisions for our school community. This partnership includes close communication and consultation to ensure the health and safety of our students, families, and staff.



Good Practices



Face Coverings & Personal Hygiene

- Masks are required on all HCS Buses & HCS Campuses when responsible distancing is not possible.
- Hand sanitizing stations at high-traffic intersections within the school building

Cleaning & Increased Sanitization

- Conduct additional disinfecting and cleaning, utilizing Environmental Protection Agency-approved virucide cleaners
- Ensure sanitization of frequently touched surfaces, such as door handles and light switches
- Perform deep cleanings during periods when few or no students are on campus or during low traffic periods

Environmental Modifications & Enhancements

- Promote use of individual (non-shared) refillable water bottles
- Increase the frequency of ventilation maintenance, including the changing of air filters and cleansing of system coils

High-Touch Considerations

- Encourage use of My School Bucks (electronic payment system) to limit physical contact through money exchange
- Encourage ticketless event accessibility where possible

Transportation

- Bus operations will run normally for the 2021-2022 School Year
- Students will be asked to keep their hands to themselves and face forward throughout the trip to school and home
- Enhanced cleaning practices will support bus safety

Building Operations

Henry County Schools is implementing a coordinated preventative disinfecting protocol in each building and office space.

If there is a scenario in which a positive COVID-19 case is identified and there has been contact with local work space, consideration for additional actions will be taken, to include:

- Continue Implementation of Preventative Practices
- If necessary, Short-Term or Long-Term Closure decisions will be made in consultation with public health officials



KEEP HENRY HEALTHY

Let's keep each other safe

Stay Well

- Hand-washing and sanitizing will be encouraged throughout the day
- All students and staff will be encouraged to respect personal space

Daily Health Monitoring

- Employees should monitor themselves and their families prior to coming to work
- Families should monitor their students and other family members before coming to school
- Do not report to school if you have a fever or any COVID-19 symptoms

Responsible Reporting

If you, or someone in your immediate family, has tested positive for COVID-19, is awaiting a COVID-19 test result, or has had direct contact with a positive case of COVID-19, REPORT IT:

- Employees should report the contact to their supervisor
- Families and students should report the contact to any school staff member

Precautionary Procedures

- Staff with symptoms suspected to be COVID-19 related should stay home and notify their supervisor
- Students with symptoms suspected to be COVID-19 related should stay home and notify their teacher or school administrator



Public Health Notification

Until further notice, Henry County Schools will notify local public health officials in all circumstances in which we receive notification of a positive test, or in other circumstances that require further consultation.

Student, Family, and Staff Communication

It is the goal of HCS to keep staff and families informed of COVID-19 positive cases impacting school and district facilities while respecting the privacy of individuals.

- For each COVID-19 positive case, close contacts will be notified by phone
- After the confidential, private notification, a general message will be shared with all staff and families connected to the affected facilities through internal and Infinite Campus messaging.

HCS Reporting Dashboard

Henry County Schools reports the number of weekly positive COVID-19 cases in our district, as well as impacted quarantine incidents in our facilities, through a dashboard on the Henry County Schools website. Additionally, the Henry County community health metrics are reviewed daily. These metrics are defined and reported on our COVID-19 Data Dashboard website. https://bit.ly/HCS_COVID_Tracker



COVID-19 Protocols for Employees

COVID-19 SYMPTOMATIC | Every employee should monitor their health daily and, if experiencing symptoms of COVID-19:

- Do not report to work
- Notify Supervisor
- Consult medical provider

COVID-19 POSITIVE TEST RESULT | If an employee is diagnosed (tested positive) with COVID-19:

- Do not report to work
- Consult medical provider
- Report diagnosis to supervisor
- Remain out of work as directed by physician and COVID-19 Response Team. Leave is entered as "sick leave."

COVID-19 EXPOSURE | If an employee reports direct exposure to a COVID-19-positive individual outside of the workplace, or if an employee is identified as a close contact during a close contact investigation at work:

If Employee is **VACCINATED**

- Immediately report exposure to supervisor
- Supervisor will immediately report (email) exposure to the COVID-19 Response Team
- Report to work
- No quarantine required
- Monitor for symptoms; if symptoms occur, notify supervisor and do not report to work
- COVID-19 Response Team may follow-up

If Employee is **NOT VACCINATED**

- Immediately report exposure to supervisor
- Supervisor will immediately report (email) exposure to the COVID-19 Response Team
- COVID-19 Response Team will determine next steps based on these variables:
 - If contact was less than 6 feet for 15 minutes or more, 10 days of quarantine required if employees are unmasked.
 - If contact was less than 6 ft for 15 minutes or more and both staff members are wearing masks, then no quarantine is required, monitor daily for symptoms.
 - If employee is asymptomatic, a negative COVID-19 test on day 5 or later may reduce quarantine time.
 - Remote work is not available and leave is entered as "sick leave."*

*Federal provisions for COVID-19 related paid leave expired on December 31, 2020 and the HCS extension of paid leave provisions expired on May 31, 2021.



COVID-19 Protocols for Students

COVID-19 SYMPTOMATIC | Every student and family should monitor their health daily and, if an immediate family member receives a COVID-19-positive diagnosis or if the student is experiencing symptoms of COVID-19, he or she should not report to school.

- Do not report to school
- Consult medical provider
- Notify a school staff member

COVID-19 POSITIVE TEST RESULT | If a student is diagnosed (tested positive) with COVID-19:

- Do not report to school
- Consult medical provider
- Report diagnosis to teacher or building principal
- Principal or designee properly reports the positive diagnosis and then conducts a close contact investigation, if needed
- Remain out of school as directed by COVID-19 Response Team

COVID-19 EXPOSURE | If direct exposure of a student outside of school is reported, OR if a student is identified as a close contact during a close contact investigation at school:

If Student is **VACCINATED**

- No quarantine required
- Monitor for symptoms; if symptoms occur, notify a school staff member and do not report to school
- COVID-19 Response Team may follow-up

If Student is **NOT VACCINATED**

- If contact is greater than 3 feet, no quarantine
- If both students are masked and contact is less than 3 feet for 15 minutes or more, then no quarantine is required, monitor daily for symptoms.
- If both students are not masked and contact is less than 3 feet for 15 minutes or more, 10-days of quarantine required
- If a student is asymptomatic, a negative COVID-19 test on day 5 or later may reduce quarantine time

Student Learning During Quarantine due to COVID-19

If a student is required to quarantine due to COVID-19, he or she will be informed of how to continue their learning through a temporary remote teacher who will provide instruction/support to stay on pace with classroom instruction. A student who participates in remote learning during an assigned quarantine will not be considered absent from school. If a student does not participate in remote learning during an assigned quarantine, he or she will be considered absent from school.

COVID-19 MANAGEMENT PLAN

Henry County Schools has a plan to advance layered mitigation strategies if local conditions of community health warrant adjustments. We will continue daily monitoring of community health conditions and school impact - along with consultation and coordination with medical authorities - as we responsibly open schools and proceed through the year. As always, Henry County Schools will adhere to any applicable federal or state executive order as required.
