Nat'l Suicide Prevention Month/Week

One issue that is a focus for many of our HCS counselors and mental health experts nationwide this month is that of suicide prevention. The month of September and the week of September 9-15 are recognized nationally as National Suicide Prevention month and week, respectively.



It is a tough topic to broach for many, but our Student Services department does a remarkable job providing resources and training for our administrators, counselors, and social workers to help recognize warning signs for all individuals to help stop an avoidable tragedy. Jessica Stormer, HCS Student Services Director, and Amy Kuhns, Director of the Henry County Counseling Center, were able to provide a glimpse into the services and support provided to students and families in our school district. Their approach for support includes intentionally building opportunities for students and families to connect with their school community and one another. Another new resource for all Henry County Schools employees is the Employee Assistance Program or EAP. Board Policy and Administrative Regulations Review Plan

One of the defining roles of any board of education is that of setting policy for the school district it governs. As a part of this role, there is a need for periodic reviews to ensure that all policies adhere to state and federal guidelines while also providing clear guidance for governance of the school district. Henry County Schools district administrators and Board Members are beginning an extensive policy review to help identify areas that need strengthening, consolidating, or eliminating due to possible redundancy or irrelevancy.

This endeavor comes at an important time in the development and establishment of the Board-Superintendent Governance Team

and the board's focus on a governance model and strategic planning process for the upcoming year. There will be policies provided for the board to review each month before sharing any ideas around modifications with the public for their consideration.

The first presentation of such a proposal started this month with the introduction of HCBOE Policy BD – Policy Development. This singular policy will be a replacement policy, consolidating five previous policies into one. It also establishes definitions to guide the work moving forward. Now policies will be further clarified with administrative regulations to support the policy's defined parameters by which the Superintendent and staff carry out their duties.

Strengthening the Core Business of Student Learning in Exceptional Student Education

All students in Henry County Schools and their success and achievements are important to the overall performance of the system. Chief Officer April Madden had the opportunity to share with the board and community the focus and responsibility her division has in meeting those needs. It starts with a partnership consisting of parents, students, administrators, teachers, specialists, and more working to ensure that our students served through the Exceptional Student Education department have all the resources needed to realize high achievement levels.

Just like their regular education peers, our students with exceptionalities have access to the Henry Teaching and Learning Standards (HTLS) and grade-level content. As it was shared, any student's academic performance should not be pre-determined by who they are and any disabilities they might have. In order to close the achievement gap that currently exists between students with exceptionalities and their general education peers, relationships must continue to be fostered between families and student support services. The Henry County Board of Education has established four core beliefs and accompanying commitments, which includes the first belief and commitment that all students can learn at or above grade level and will have equal opportunities to do so. The board made a key move with the recent passage of the FY19 budget which allowed for greater, more direct support of our schools and students by placing the Student Support Facilitators in the schools they serve. This move, coupled with consistent reviews of the content delivery and support, will empower teachers and paraprofessionals by strengthening instructional practices, and subsequently increase the learning expectations and outcomes for ALL students.

Awards and Recognition for Teachers and Staff







HENRY COUNTY SCHOOLS BOARD MEMBER REMARKS


- Locust Grove HS students were a big part of Dr. Nutt's comments. She noted that Khi Watson,
