### **General Information**

The Department of Learning and Performance is sending this communication to update schools on the latest information surrounding Georgia Milestones Assessment.

We have included areas that have been updated so that schools are aware of the changes and resources available. Please take appropriate steps in your building to ensure all stakeholders aware. You may want to pay close attention to the changes in the use of Desmos as a technology tool during testing and the technology enhanced items.

### **Georgia Milestones Updates & Resources**

### **Desmos Calculators**

Beginning with the winter 2019 administration, the calculators for Georgia Milestones assessments are changing to Desmos calculators. Desmos provides publicly available calculators that students can use in the classroom and at home by accessing <a href="www.desmos.com">www.desmos.com</a>. Desmos calculators provide a seamless resource to use for both instruction and assessment. The Georgia Milestones <a href="calculator policy">calculator policy</a> has not changed.

We would advise schools to use the Desmos tool with students as frequently as possible ahead of the winter and Spring EOG/EOC administrations. We want to avoid allowing the technology to be a barrier in receiving accurate student achievement levels. Please refer any questions you may have to our Math Coordinator – Ms. Towanda James.

## **Milestones Technology Enhanced Items**

**Technology Enhanced Items** were field tested during the spring 2019 Georgia Milestones assessment. These items were reviewed and *will now be a permanent part of the Milestones assessment*.

The new items will also be included in the Georgia Milestones Online Experience starting in Mid-November. We would encourage schools to take advantage of this opportunity to review and practice these items with your students.

### **Georgia Milestones Assessment Guides**

**Assessment Guides** for all content areas have been updated in 2019 with changes to the assessment design tables to reflect the increase in technology-enhanced items. The new narrative writing checklists are also available in the Assessment Guides.

- End of Grade Assessment Guides -These Assessment Guides are provided to acquaint Georgia educators and other stakeholders with the structure and content assessed on the End of Grade (EOG) measures.
- End of Course Assessment Guides These Assessment Guides are provided to acquaint Georgia educators and other stakeholders with the structure and content assessed on the End of Course (EOC) measures.

### **Milestones Achievement Level Descriptors**

ALDs are narrative descriptions of the knowledge and skills expected at each of the four achievement levels and were developed for each grade level, content area, and course; <u>ALDs can be accessed here</u>. It is important to understand that a student should demonstrate mastery of the knowledge and skills within his/her achievement level as well as all content and skills in any achievement levels that precede his/her own, if any. For example, a Proficient Learner should also possess the knowledge and skills of a Developing Learner and a Beginning Learner.

The Assessment Department and the four Core Content Coordinators have been providing ALDs professional development to teachers this fall via Content Department Chair meetings, and IPLLs will receive this training in an upcoming meeting, so it can be redelivered within your buildings.
