MINUTEMAN SCHOLARSHIP

The Minuteman Scholarship is a Reserve Officer's Training Corps (ROTC) Guaranteed Reserve Forces Duty (GRFD) scholarship that was introduced in 2015 to enhance the Army Reserve's ability to recruit highly qualified cadets every year. All qualified applicants for ROTC scholarships may apply for consideration for a Minuteman Scholarship.

The Minuteman Scholarship covers full tuition and fees (uncapped) or \$10,000 per year toward room and board at any college or university served by an Army (ROTC) program. Scholarship recipients also receive a yearly book allowance of \$1,200 and a monthly stipend of \$420 while attending school enrolled in the ROTC program. Minuteman Scholarship recipients must serve in the Simultaneous Membership Program (SMP), in which they participate in an Army Reserve unit's monthly drills and a 14-day annual training for which they are paid as a E-5/Sergeant. After graduation and commissioning, Minuteman Scholarship recipients are guaranteed placement in the Army Reserve.






REQUIREMENTS

- ★ Currently in the Army Reserve or eligible for enlistment
- ★ Be a U.S. citizen
- ★ Between ages of 17-30
- ★ Valid Chapter 2 MEPS physical
- ★ Ability to pass Army Physical Fitness Test (APFT)
- ★ Meet Army Regulation 600-9 standards
- ★ Acceptance letter to a college or university with a ROTC program
- ★ Professor of Military Science validation
- ★ 4YR scholarship for non-prior service applicants require: 2.5 GPA SAT-1200 and/or ACT-24
- ★ If established college GPA or MOSQ; 1000 SAT, 19 ACT, 2.5 GPA
- ★ Nomination letter from an Army Reserve Ambassador, Army Reserve MSC CDR, or Civilian Aide to the Secretary of the Army
- ★ Enroll in ROTC
- ★ Participate in Simultaneous Membership Program (SMP)
- ★ Once commissioned…8-year service obligation
