## STUDENT PARKING RULES/REGULATIONS

- 1. Granting of parking permits is a privilege and not a right.
- 2. The parking area at school is part of the school and is owned and regulated by the Henry County Board of Education.
- 3. The Board of Education is not responsible for automobiles or their contents.
- 4. Any student parking automobiles on school property during school hours must be registered with the school and must display a current decal on the inside of the car.
- 5. Any student driving vehicles on school property **MUST** be licensed and covered by a valid insurance policy.
- 6. Student shall park in the **Student** parking lot in the correct numbered space. Cars without permits and cars parked in unauthorized areas will be towed at the owner's expense. <u>No</u> refund will be given.
- 7. Any student who accrues excessive tardiness and/or absences, fails to follow proper check-in/out procedures, are caught being in an unauthorized area, who transport other student(s) off campus without permission, or break an attendance contract will lose their parking privilege for the remainder of the school year. Permits are non-transferable.
- 8. Once the vehicle is parked, student is required to go immediately to their designated class. **No loitering** will be permitted in the parking lot before or after school.
- 9. Student is not to return to their vehicle once on campus without a pass from an administrator.
- 10. While the vehicle is parked on school property or being driven on school grounds, the driver will obey all traffic regulations and signs.
- 11. Student will report any changes to registered vehicle information.
- 12. Student will properly display their assigned parking decal <u>inside the car on the rear view</u> mirror for parking security.
- 13. While a student's vehicle is on school property, the principal or designee has the right to search the vehicle without obtaining permission of the student or the owner of the vehicle.
- 14. There will be a \$5.00 charge for any replacement of a parking decal.
- 15. The Henry County Board of Education may periodically change the rules and regulations governing the use of the facilities and automobiles. The undersigned will be bound by such changes whether a part of this application or not.
- 16. Parking permit fee is \$50.00 for 2019-2020 school year.
