What Is Title I?



- Title I is the largest federally funded program for elementary, middle and high schools
- It is part of the Every Student Succeeds Act (ESSA).
 - The purpose of Title I under the ESSA is to ensure that all children have a fair, equal, and significant opportunity to obtain a high quality education and reach, at a minimum, proficiency on challenging state academic achievement standards and state academic assessments.
- Title I Schools are determined by the percentage of students receiving free or reduced lunch.
- Tussahaw Elementary is a School-Wide Title I school.

What are some benefits of being a Title I School?

Increased student achievement by engaging and empowering parents, as well as other stakeholders, to become actively involved in their children's education. The focus is on helping all students meet the same high standards expected of all children.

- Parent/Family Resource Room offers free resources for parents

Value of Parent Input

It is the law:

Title I requires that parents are to be "afforded substantial and meaningful opportunities to participate in the education of their children." All parents of eligible Title I children must be provided the opportunity to provide feedback and input into and on Title I budgets, plans, and compacts.

- Parents work more closely with their children than other adults can
- Involved parents not only help their own child, but all children in a school
- Parents are the only adults in the education process who have been and will continue to be deeply involved throughout the child's school career
- Parents provide critical input that only they can bring; they know their child better than anyone else
- While parents may not be educators themselves, they bring their years of experience in other professions and aspects of life to the process

Our CCRPI Results

What is the College and Career Ready Performance Index (CCRPI)?

CCRPI is a comprehensive school improvement, accountability, and communication platform for all educational stakeholders that will promote college and career readiness for all Georgia public school students.

- Our 2019 CCRPI was 69.5
- Our 2018 CCRPI was 60.3

On March 27, 2020, the United States Department of Education approved Georgia's request to waive statewide assessment, accountability and reporting requirements in the Elementary and Secondary Education Act (ESEA) for the 2019-2020 school year due to widespread school closures related to the novel Coronavirus disease (COVID-19). Therefore, there are no 2020 CCRPI reports

• We are still non-designated through Title I which means we are continuing to provide a quality education to all of our students.


Tussahaw Elementary School's 2021-2022 School-Wide Plan


Overview of 2020-2021 School-wide Title I budget
